Schedule 1-Customer Terms and Conditions 附表 1 客戶條款細則

1. I am aware that the period of first monthly fee counts from the effective date to the last day of the month, and I know that the minimum subscription period is one month, and there is no refund policy.

本人知悉首月月費是由啟用服務當天至該月尾為止,不足1個月亦以整月計算。

- 2. I know that if the debt is incurred after deduct the service fee, that debt will generate interest. 本人知道因申請行情費用所產生的欠款,將會產生戶口利息。
- 3. Shanxi Securities International Limit (「SSIL」) will deduct monthly fee at the effective date of real time quotation service.
